Once completing the above then proceed to start holding area at Theatre Clwyd 117/ 241 /652 (underground car park, diagram attached) and park as diagram. Signing on facilities (open from 18.15) are within the Clwyd room of Theatre Clwyd, please proceed in here visiting marshal signing on first. Please note the 'No Marshal/No Start rule will be STRICTLY ENFORCED.

Then proceed through competitor signing on etc.

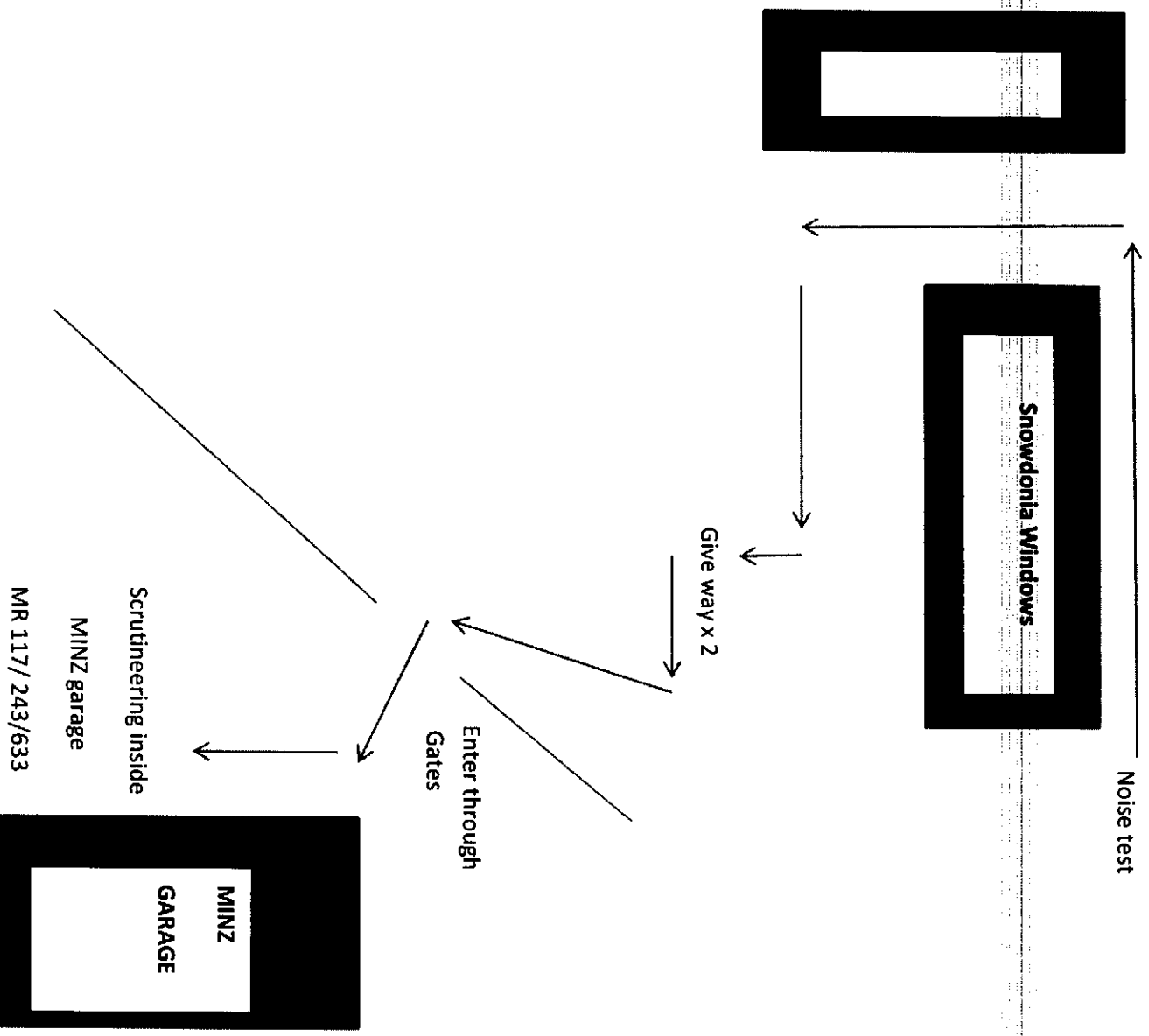
**Spectator information and Maps:**

Please fuel cars before entering Start car park as you will not be allowed to leave once within the underground car park.

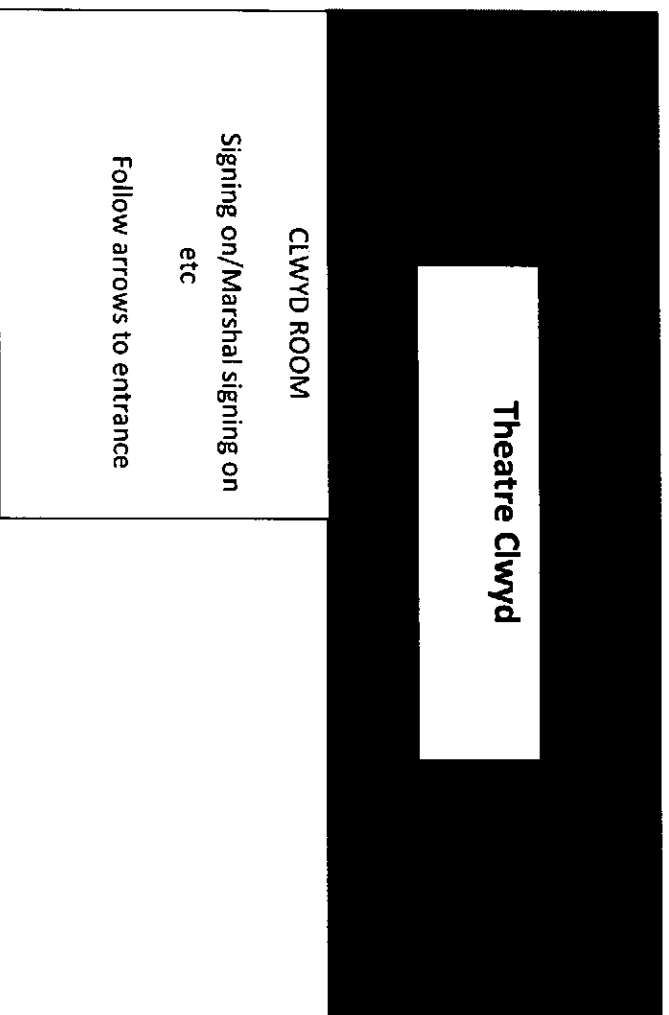
